What is backup withholding?

Backup withholding is required if you are a nonresident alien individual, a foreign partnership, or a nonresident alien entity that is not a corporation and you have not provided your correct taxpayer identification number (TIN) to the payer.

Caution: If you are a nonresident alien individual, a foreign partnership, or a nonresident alien entity that is not a corporation and you have not provided your correct TIN to the payer, the payer is required to withhold tax on any payments made to you.
